

As the Navy continues its critical mission during the coronavirus pandemic, NAVWAR's cyber-secure networks are even more important to worldwide Fleet operations. The Navy is rapidly expanding capabilities for naval personnel to continue their mission remotely, wherever possible, while maintaining recommended physical distances as we are able to slow the spread of coronavirus.

# **Latest Information on Draft EIS**

The Navy anticipates releasing the Draft EIS for public review and comment in late 2020, and the Final EIS and Record of Decision in 2021. The scale and complexity of this project requires complete and validated technical studies to support the robust analysis. The Navy will continue to update the public on our progress in developing the EIS.

The next opportunity for public participation will occur in late 2020 when the Draft EIS is released for public review and comment. The Navy is exploring options for virtual public engagement. The Navy will continue to engage with the public through email notices such as this, attendance at virtual community meetings, and regular updates to the project website. Once stay at home guidelines are lifted, the Navy will resume attendance at community planning group meetings and other events.


